MNMRC CO-MANAGES HUI O KA WAI OLA, A UNIQUE COMMUNITY-BASED OCEAN WATER QUALITY MONITORING PROGRAM THAT TESTS COASTAL SITES EVERY THREE WEEKS ACROSS LEEWARD MAUI. IN 2024, THE PROGRAM EXPANDED FROM 35 TO 41 SITES, INCLUDING CONTINUED MONITORING AT SEVEN LOCATIONS IN LAHAINA TO ASSESS ONGOING IMPACTS FROM THE 2023 WILDFIRE. THE HUI ALSO COMPLETED ITS FIRST FULL YEAR OF MONITORING ON THE NEIGHBORING ISLAND OF LANAI. ALL DATA ARE COLLECTED UNDER STRICT QUALITY ASSURANCE PROTOCOLS AND SUBMITTED TO THE HAWAII DEPARTMENT OF HEALTH CLEAN WATER BRANCH. SINCE LAUNCHING IN 2016, HUI O KA WAI OLA HAS COLLECTED OVER 4,822 WATER SAMPLES TO HELP GUIDE POLLUTION MANAGEMENT, RESOURCE PROTECTION, AND COMMUNITY AWARENESS.

IN PREPARATION FOR ESTABLISHING COMMUNITY-BASED CORAL REEF AREAS IN NORTH KIEHI, MNMRC LED COMMUNITY OUTREACH, DEVELOPED SITE PLANS, AND CONDUCTED TRAINING IN REEF RESTORATION TECHNIQUES.
